Discussion of further support for the "Vote 'Yes' for Fair Tax" Movement	There was considerable discussion/debate about whether and how best to offer an online presentation describing the benefits of voting "Yes" in the election for the Fair Tax Amendment. Allison Flanagan from CTBA was suggested as a possible presenter for a GSU-SUAA customized presentation, possibly with interactive narration from Addison, but then there would be the issue of how to insure enough online "audience" to justify that kind of effort. It was mentioned that there are already a multitude of very well done online presentations by union supporters, such as UPI/IFT, and the Vote Yes for Fairness coalition, so maybe just sending a persuasive e-mail to members with hot links to these presentations is a much easier way to inform anyone still uncommitted on this issue.
