Discussion of Possible Need to Change Banks for Our Chapter Treasury:	Jane (Treasurer) is having significant difficulty setting up an online mobile phone option for accessing our Bank Financial Treasury account at a distance from their branches as a regional bank. She would like to consider moving our Treasury account to a larger, more global institution, such as Citibank, Chase or Fifth Third, that uses more sophisticated, user friendly virtual software. A motion was made and seconded to allow Jane and Bill to move the account as necessary if problems with Bank Financial persist.
